- that whilst Brand_Line will use its best endeavours as aforesaid, the establishment of the Scheme and the supply chains in the Republic of South Africa are still in development and Brand_Line cannot, primarily by reason of circumstances outside of its control, always guarantee that all deliverables will be met;
- that insofar as this applies to you, Brand_Line will use its endeavours as aforesaid in relation to all of the volumes which you purchase from it or from other Producers of the Scheme;
- the Founder Members of the Scheme will publish regular reporting of the achievements of the Scheme on its website and via other media channels for you to access;
- the Scheme will, from time to time, engage with you in relation to the implementation of projects and programmes that are important to you, including enterprise development initiatives and opportunities;
- the Scheme will, in pursuit of its objects of creating relatable identification of waste streams for the waste stream value chain, produce informational and marketing material, and the Founder Members may from time to time reference your membership and, where appropriate, display your brands or logos to achieve this relatable identification;
- the Founder Members will deliver to you, the Scheme's logo, to use by you, subject to prior written approval by the Founder Members; and
